RESEARCH METHODS IN PSYCHOLOGY 1

1 Calendar Description

This course will introduce students to the variety of ways to conduct research in psychology. Topics to be covered include the scientific approach to testing psychological theory; ethical issues in psychological research; developing and planning research projects; basics of measurement; survey research; best practices in research conduct.

Antirequisites: the former Psychology 2800E, the former Psychology 2820E, Psychology 2830A/B, Psychology 2840F/G Psychology 2855F/G, Psychology 2856F/G, Health Sciences 2801A/B.

Prerequisites: At least 60% in 1.0 credits of Psychology at the 1000 level; a passing grade (i.e., at least 50%) in [Data Science 1000A/B](#) and a passing grade (i.e., at least 50%) in 0.5 credit of Year 1 Math from among the following courses: [Calculus 1000A/B](#), [Calculus 1301A/B](#), [Calculus 1500A/B](#), [Calculus 1501A/B](#), [Mathematics 1225A/B](#), [Mathematics 1228A/B](#), [Mathematics 1229A/B](#), [Mathematics 1600A/B](#), or [Applied Mathematics 1201A/B](#). Students without [Data Science 1000A/B](#) may enrol with 0.5 credit of [Applied Mathematics 1201A/B](#) and 0.5 credit of [Computer Science 1026A/B](#) with a grade of at least 60% in each. Students who have completed [Statistical Sciences 1024A/B](#) (or other introductory statistics course in addition to 0.5 credit of Year 1 Math) instead of [Data Science 1000A/B](#) may enrol after completing an introductory programming class from the following list: [Computer Science 1025A/B](#), [Computer Science 1026A/B](#), [Computer Science 2120A/B](#), [Data Science 1200A/B](#), [Digital Humanities 2220A/B](#), or [Engineering Science 1036A/B](#). [Data Science 2000A/B](#) may be substituted for [Data Science 1000A/B](#) for students entering the program with 1.0 credits of Year 1 Math courses.

2 lecture hours; 2 laboratory hours; Course Weight: 0.5

4 Course Objectives and Learning Outcomes

This course introduces the ways in which research is conducted in psychology. We shall consider a range of available research methods, including observation, archival research, questionnaire surveys, case studies, and experimentation. We'll also consider topics closely allied to research design, such as ethics, report writing, and data presentation. In addition to providing training in research techniques needed for third- and fourth-year psychology courses (e.g., Psychology 4850), it is expected that Psychology 2801F will contribute significantly to the development of scientific thinking skills that students can apply to their future careers and in everyday life.

5 Evaluation

The course requirements, along with relative weightings in the determination of final grades, are:

- Midterm 25%
- Final Exam 40%
- Laboratory Activities 35%

The evaluation and testing formats for this course were created to assess the learning objectives as listed in section 4 and are necessary for meeting these learning objectives. All evaluations listed in this course outline are required components of the course and together account for 100% of the final grade. Weightings and assessment formats may be adjusted where required to support course learning objectives, with appropriate notice to students.

Policy on Missing Coursework

Exams. Students who receive academic consideration for an exam will be given an opportunity to write a makeup exam. The makeup may adhere to a different format from the original exam.

Laboratory Activities. For each laboratory topic, there are two labs: a practice lab, marked for completion only (worth 1% each – 5% total), and a timed lab assignment that will be graded for quality (worth 6% each – 30% total). All laboratory activities must be completed and submitted entirely during class. Submissions will not be accepted outside of class. If you receive academic consideration for a lab, the weight of the missed lab will be reassigned to the other labs of that category. That is, a missed practice lab with consideration will result in the remaining four practice labs being worth 1.25% each. A missed lab assignment with consideration will result in the remaining four lab assignments being worth 7.5% each.

Because this is an essay course, as per Senate Regulations, you must pass the essay component to pass the course. For this course, the essay component refers to the graded lab assignments. Your average mark across these five assignments must be at least 50%.

Course grades within the Psychology Department are expected to be distributed around the following averages:

70%	1000-level to 2099-level courses
72%	2100-2999-level courses
75%	3000-level courses
80%	4000-level courses

In the event that course grades are significantly higher or lower than these averages, instructors may be required to make adjustments to course grades. Such adjustment might include the normalization of one or more course components and/or the re-weighting of various course components.

Policy on Grade Rounding

Course grades are rounded to the nearest whole number. No additional assignments will be offered to enhance a final grade. Requests to change a grade because it is needed for a future program will not be considered.
